I, _____, the undersigned applicant, do hereby voluntarily submit my application for attendance at and participation in the 4th International Chicago Wushu-Gong Fu Tournament and United States of America Wushu Kungfu Federation, Inc. ("USAWKF") National Championships and seminars (the "Event"). I understand that participating and/or competing in a martial arts event is an inherently dangerous activity and can result in serious injury or death. I hereby assume the risk and full responsibility for any and all damages, injuries, or losses that I may sustain or incur while attending and/or participating in the Event. I agree and understand that my participation and or competition in the Event is completely voluntary, and that I must report any and all injuries immediately to the Event staff.

I further agree that USAWKF, Inc., ICWGT, Chinese Gong Fu Institute, Niles West High School, District 219, and their respective officers, agents, representatives, members, servants, employees, and volunteers ("Releasees") shall not be liable to me or my personal representatives, assignees, heirs, and next of kin for any claims, demands, injuries, damages, actions, or courses of action whatsoever, to my person or property, arising out of or in connection with my participating or competing in the Event or the premises where the Event is held. Further, I do expressly hereby forever release and discharge said Releasees, and covenant not to sue said Releasees, from or for any and all claims, demands, injuries, damages, actions, or courses of action, and from or all acts of active or passive negligence or gross negligence on the part of said Releasees in connection with my participation and/or competition in the Event.

I further agree to indemnify and save and hold harmless said Releasees and each of them for any loss, liability, damage, or cost they may incur due to my participating or competing in the Event and whether caused by the negligence or gross negligence of said Releasees or otherwise.

I fully understand that in the event any medical attention or treatment is afforded to me by said Releasees, or any other person or entity, it will be of first aid type only, and I hereby release and discharge said Releasees and all other persons or entities, forever from any liability whatsoever for any such aid.

I agree that my performance, attendance, and participation at the competition may be filmed or otherwise recorded or telecast live. I consent to the use by ICWGT, Chinese Gong-Fu Institute, and United States of America Wushu Kungfu Federation, Inc. of my name, likeness, voice, poses, pictures, and biographical data concerning fully or in parts, in any form or language, with or without other material, throughout the world, without limitation, for television, radio, video, theatrical motion pictures, or any other medium by devices now known or hereafter devised, and I do hereby waive any compensation in regard thereof as well as any future rights to the aforementioned.
